## **SYLLABUS**

# CHRISTIANS, JEWS AND MUSLIMS IN SPAIN

#### 1. Introduction

This course employs a historical approach to the study of the three Abrahamic faiths -Judaism, Christianity and Islam- and their coexistence in al-Andalus and the rest of Medieval Iberia. This period has been paramount in the formation of not only of modern Andalusia but also of the modern Spain. Throughout the course students will analyze the evolution of the complex relationship between these three religions in Iberia with respect to political, economic, religious, cultural and artistic parameters. The course will also focus on how what happened in Iberia in the Middle Ages can be used to understand the present situation of Spain, and the world, and how concepts such as *Convivencia* can be of use in the 21st century.

#### 2. Course Objectives

The main aim of this course is that students analyze and understand Judaism, Christianity and Islam within their own historical contexts, as well as how the relationship between these three religions shaped Medieval Iberia and still shapes our world. The cultural legacy of the three religions is becoming more alive in the Mediterranean basin and, in this sense, Spain is one of the countries from which the student can draw conclusions.

#### 5. System of Evaluation

## 5.1 Attendance and Participation (20%)

# 5.2 Written and Oral Assignments (40%)

- **5.2.1 Midterm Essay (20%):** A six-s essay on a topic suggested by the lecturer. The essay must be written in **MLA** format.
- **5.2.2 Final Essay (20%):** A six-pages essay on a topic suggested by the lecturer. The essay must be written in **MLA** format.
- 5.2.3 Exams (40%)
- **5.2.3.1 Midterm Exam (20%):** The exam is composed of 15 questions of which students must choose and answer only 10.
- **5.2.3.2. Final Exam (20%):** The exam is composed of 16 questions of which students must choose and answer only 10.
- **6. Assignment Policies:** All papers and projects, including any homework, are due at the beginning of class on the due date listed or assigned. Any assignment not turned in at that time is considered late. The title is to be written in Bold, 12 pt Times New Roman. Paper should generally be 5-8 pages long, including title, figures and works cited.
